## **Description:**

This course is an introduction to the economics of globalization. We will cover the fundamental material about international trade, foreign direct investment, international migration, exchange rates and global finance. We will combine study of basic economic theory as applied to these topics, with the discussion of historical and contemporary experiences. We will relate the concepts we learn to contemporary issues such as the Euro-zone debt crisis, the international dimensions of the U.S. economic crisis, the ratification of bilateral trade agreements (e.g. US-South Korea or US-Colombia), and the lack of progress on a new multilateral trade treaty, illegal immigration, and the offshoring of manufacturing and service jobs. We will conclude the course with a study how economics illuminates the difficulties in reaching an international accord to deal with climate change.
